## VENDOR CONTRACT

In consideration for the right to sell goods or services at the below listed Murrieta Valley Girls Softball Association event (hereinafter "Event"), the Murrieta Valley Girls Softball Association (hereinafter "MVGSA") and the undersigned (hereinafter "Vendor") agree to the following:

1. MVGSA will provide locations, times and dates for the Event to the Vendor at the signing of this contract.
2. Vendor will pay Event Fee of \$\_\_\_\_\_, payable 45 days prior to the Event. Vendor fully understands that there is a return check fee charge and all returned checks (including return fee) must be paid in full to be allowed to participate in Event if this occurs. Vendor has until 10 days prior to Event to cancel and have Event Fee refunded. There will be no refund of Event Fee should Vendor cancel, for any reason, within 10 days of Event.
3. Vendor will not be allowed to place material, sell products, or advertise thru use of flyers or business cards unless an Event Fee has been paid and authorized by a designated member of the MVGSA Board of Directors..
4. Vendor will provide own set up materials, products, displays and associated tables/chairs and any weather protecting devices (EZ Ups/Umbrellas).
5. MVGSA does not guarantee a minimum sales amount to the Vendor and MVGSA is not responsible for damage, theft or loss of Vendor merchandise or equipment during the Event.
6. MVGSA is not responsible for non-payment, insufficient funds, declined credit cards for merchandise or services purchased from the Vendor at the Event.
7. The Vendor agrees to defend and indemnify MVGSA, its Board of Directors, agents and associates, and agrees to hold each and every one of them harmless from and against any and all lawsuits, claims, demands, losses, damages, liabilities, costs and expenses, including attorney fees and legal costs, arising from the Vendors negligence, misconduct, representations, warranties, agreements or any performance made to their customers with regards to the said Event for which this contract is agreed.
8. Vendor will not sell products or services that MVGSA deems as inappropriate, offensive or demeaning in nature.
